ORDER

WHEREAS, Sri Y.N. College of Education, Narasapur, West Godavari – 534275, Andhra Pradesh has submitted as application to the Southern Regional Committee of NCTE for grant of recognition for offering B.Ed course of one year duration with an annual intake of 100 students on 18.09.2007 and the recognition was granted to the institution on 18.09.2007.

AND WHEREAS, on 31.12.2014, a letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised Norms and Standards before 31.10.2015.

AND WHEREAS, on 03.02.2015, the institution has submitted the affidavit for offering B.Ed course with an intake of 100 students.

AND WHEREAS, the SRC in its 276th meeting held on 7th – 9th January, 2015, decided to issue provisional Recognition orders to the existing institutions as and when the affidavits are received by this office. The SRC also decided to place the consolidated lists of cases to the Committee for ratification subsequently. The Committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection.

AND WHEREAS, a Revised Recognition order was issued to the institution on 06.05.2015.

AND WHEREAS, the institution has submitted its written representation on 30.04.2016.

AND WHEREAS, the SRC in its 321st meeting held on 28th -30th September, 2016 considered the matter and decided as under:

- We should use this opportunity to verify the basic facts with respect to documents in all such RPRO cases many of which relate to very old FRs issued by us. R.D may collect – Land deeds ; LUC ; EC ; BP ; BCC ; FDRs ; and , Faculty Lists and get them processed by office so that we can critically scrutinize the facts and take appropriate decisions about issue of new FRs.

AND WHEREAS, as per decision of SRC a letter was sent to the institution on 24.10.2016.


AND WHEREAS, the institution has submitted a letter dated 14.02.2017 and 06.02.2018, regarding requesting reduction from 2 units to 1 unit received by this office on 12.02.2018 .

AND WHEREAS, the SRC in its 359th meeting held on 17th & 18th, May 2018, again considered the matter and decided as under:

1. This is a RPRO case.
 - 1.1 In our scheme of functioning, we gave priority to new cases and RPRO cases were kept pending.
 - 1.2 But the reduction from 2 units to 1 unit part of it must have been segregated by the SRO since it has faculty implications for the college.
 - 1.3 We regret the inconvenience caused to the college by the delay.
 - 3.1 We accept their request for reduction from B.Ed (2 units) to B.Ed (1 unit) w.e.f. 2018-19.
 - 3.2 Issue a formal order accordingly.
 - 3.3 Correct our records and the FR accordingly.
 - 3.4 Inform the University concerned.
 - 4.1 This reduction will not however, affect the students in the 2nd year of the course. The Faculty reduction will accordingly be phases.
 - 4.2 Request the affiliating University to particularly monitor this point.

NOWTHEREFORE, the request of the above said institution for reduction of intake from 2 Units to 1 Unit in the B.Ed course is herewith permitted.
