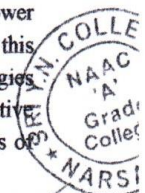
WHEREAS:

K. Non – exclusivity



In witness whereof, the parties have executed this MoU and represent that they approve, accept, and agree to the terms contained herein.




