#### **SCOPE:**

**Responsibilities of Party1: (Godavari Mega Aqua Food Park Pvt. Ltd.)**

- 1) To provide project work training to the students in HR, Marketing, Finance Management, Chemistry, Organic Chemistry, Zoology, Fisheries, Microbiology, Bio-technology operations.
- 2) To bring awareness to the students on Start-ups, business growth and Artificial Intelligence (AI).
- 3) To provide business plans to the students of MBA. MCA. BBA. and Commerce Students.
- 4) To conduct entrepreneurship skills development programs for the students.
- 5) To facilitate field trips & visits.
- 6) To give awareness about research works to the students.
- 7) To give collaborative programs, seminars and research activities will be encouraged and supported. Where the mutual interests an expertise of both institutions may be furthered.

- 4) This Memorandum of Understanding is an agreement between both parties and does not create or confer any right or benefit on any person or party, private or public.

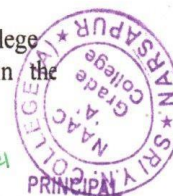
