**The Both Parties agree that:**


The Parties shall diligently perform their respective obligation under the MoU as per the procedure set forth above.

This MoU shall become effective from the date hereof and shall be in force for a period of Two years.

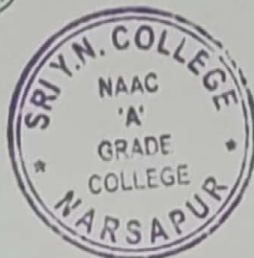




