- 2) Either party is free to withdraw at any time during the initial period with prior written notice to the other party of its intention to withdraw.

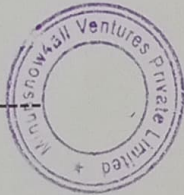

Amendments



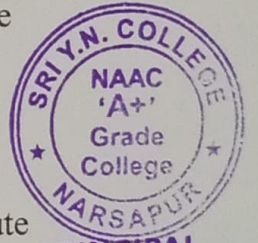


