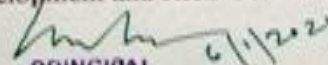

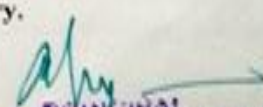

**CLAUSE 1**

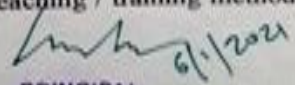
**CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related academic fields. **SCOPE OF THE MOU**

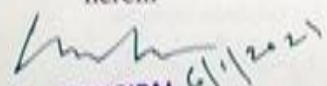
- 2.1 The upcoming young graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of achieving academic excellence at par with International Standards. ### CLAUSE 3 INTELLECTUAL PROPERTY

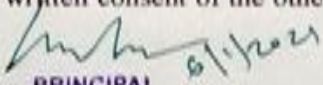

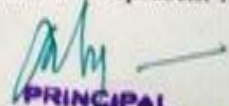
### CLAUSE 4 VALIDITY
