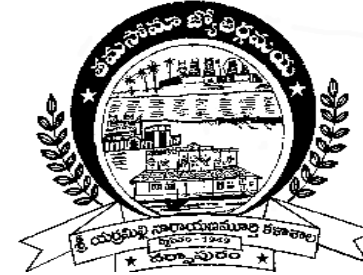

INTRODUCTION

Sri Y.N. College, established as an Intermediate College in 1949, is situated on the bank of river Vasista Godavari in a serene atmosphere ideally suited for the pursuit of Higher Education. It is one of the oldest colleges in Andhra University area. It attained the status of a full-fledged Degree College in 1956 and was elevated to Post-Graduate level in the year 1989-90, with three P.G. Courses. Now it offers Seven P.G courses. The college has evolved into a premier institution of higher education in this region. The Institution has been recognized by UGC as one of the lead colleges.

The College was accredited by NAAC with "A" grade in the year 2004. It attained the status of Autonomous College in the year 2007. It was reaccredited by NAAC at 'A' grade with a CGPA of 3.40 and was selected for the award of "College with Potential for Excellence" by UGC in 2010 and reaccredited by NAAC at 'A' level for the third time in the year 2017 with a CGPA of 3.41.

In the 1940's Late Sri Yerramilli Narayana Murthy Pantulu garu, an eminent lawyer and philanthropist, and other elders of the town entertained the idea of starting a College at Narsapur, and took a decision in the meeting presided over by Sri GM Gupta, the then president of Narsapur Panchayat. Due to their indefatigable efforts, the College was started in June 1949 with Sri Yerramilli Narayana Murthy garu as its Founder Secretary. The College was named as "The Narsapur College". It was temporarily located in the premises of the local Taylor High School. The College started functioning during the academic year 1949-50 as an Intermediate College with traditional courses in Humanities and Sciences. The College underwent teething troubles due to financial constraints and lack of infrastructure.

By 1956, due to the untiring efforts of the Founder Secretary and Sri Grandhi Venkata Reddy Naidu, former Law Minister, the Government of Andhra Pradesh issued GO Ms No. 2341 to the Revenue Department, Narsapur, dated 22.10.1955 alienating an extent of 12.3 Acres of site along with the then Sub Collector's bungalow (Dutch Building) to the College. The College gratefully acknowledges the untiring efforts of late Sri Grandhi Venkata Reddy Naidu, who was instrumental in the College getting the site.

The Dutch building, presently the main building of the College, has historic significance of being constructed in the 18th century by the Dutch, when they were trading with India. Narsapur was then a port town with shipping activity.

In 1956, the College was elevated to Degree Level with traditional courses in Science, Humanities and Commerce. The College got permanent affiliation by the University in the year 1961. Throughout the initial turbulent and testing times, Sri Yerramilli Narayana Murthy garu shouldered the responsibility as the Secretary and Correspondent laid strong foundations for future development. And after his death in the year 1967, the College committee in grateful acknowledgement of the services rendered by him, and to perpetuate his memory, rightly decided to re-name the College as Sri Yerramilli Narayana Murthy College (Sri YN College), Narsapur. Sri Vanguri Subba Rao garu as the first Principal served the College for 12 years and strived hard in achieving academic excellence in spite of financial constraints and lack of infrastructure .

When there were financial constraints in the initial stage, the agricultural landholders and ryots of Narsapur area contributed one bag of paddy per acre. Later in the year 1962, Circar Agriculture Development Corporation. Gollavanithippa, gave financial support to the College.

Successive managements under the leadership of Sarvasri Javvadi Lakshmaiah Naidu, Dr Kosuri Adinarayana, Ch. Reddeppa Dhaveji, Ch. Lakshmi Narasimha Dhaveji and Dr. MS Sastry, as Secretary & Correspondents made a significant contribution for the progress and development of the College. During their time, Biological Sciences Block, Physical Sciences Block, Silver Jubilee Buildings 1 and 2, Non Resident Student Centre, Auditorium and Gymnasium were constructed.

In the year 1960, late Sri Bolla Veera Raghavulu, former Governing Body member, donated to the College a Mangalore tiled house situated on the eastern side of the College campus (subsequently the house was removed).The College purchased Pilla vari site with an old tiled house (subsequently removed) situated in the northeast corner of the College in 1976.

Dr. Chinamilli Satyanarayana Rao, Secretary and Correspondent, and his team, tuning to the changing needs of the youth in Higher

education, introduced restructured courses like Electronics, Fisheries, Computer Science, Biotechnology, Microbiology, Biochemistry, Geography and BCA at Degree level and Vocational Courses at Intermediate level. The College was elevated to PG level in 1989-90. Initially M.Com, M.A. (Eng) & MA (Pub-Admn.) (1989-90) were started. Later, in the course of time, a few other prestigious courses like MBA (1992), MCA (1993), MSc (Maths) (1995-96), MSc (Electronics) (1996-97), M.Sc. (Computers) (1999-2000), M.Sc (Information Science) (2001-02), M.Sc (Microbiology) (2005-06), M.Sc (Biotechnology) (2006-07) and M.Sc (Organic Chemistry) (2010-11) were started. The dynamic Management under the leadership of Dr.Chinamilli Satyanarayana Rao, as Secretary and Correspondent constructed many new buildings and provided necessary infrastructure, and well equipped Labs for all the new courses at U.G. and P.G. levels. The credit of constructing the South West Block, U.G.Library Building, PG Library Building, Alumni Golden Jubilee Building, UG Golden Jubilee Building, PG Courses Building, MBA Building, Administrative Block, Two Women's Hostels and North West Block, goes to the management under the leadership of Dr. Chinamilli Satyanarayana Rao garu. To the credit of the college, Electronics, Computer Science, Fisheries at Degree level, and M.A (English), M.A (Public Administration), MCA, MSc. (Ele), MSc (IS) at PG level were introduced in the very first batch among Andhra University affiliated Colleges. In addition to these courses, B.Ed. course was also introduced in the year 2007 & D.El.Ed. in 2015. The College has an ample scope for expansion and construction of new buildings and introduction of new courses.

The College provides Support Services to the students, like Physical Education, NCC, NSS, Community Service Centre, Yoga and Health Centre, IQAC, Women Empowerment Cell, Jawahar Knowledge Centre, Literary and Fine Arts Association, Grievance Redressal Cell, Career Oriented Programmes and Gandhian Studies Centre, Sponsored by UGC. HRD Centre (Skill Development & Placement Cell). The College has also Andhra University Distance Education Centre. 24 hrs Mineral water facility is provided for the students of UG, PG, Intermediate, B.Ed. & D.El.Ed.

The low-lying playground on the southern side of the College with downward slope towards the River Godavari was levelled by filling the

ground and the playground is made useful for playing in all seasons. Facilities are provided to the students for various games and sports including an Indoor Shuttle Court, Tennis Court and Multi-Gym.

The College celebrated its Silver Jubilee in 1979, Golden Jubilee in 2000 and Diamond Jubilee in the year 2010. Dr. C.S.Rao PG Centre Celebrated its PG Silver Jubilee in 2016. At the time of the Golden Jubilee celebrations and PG Silver Jubilee Celebrations the Alumni of the College made significant financial contribution for the development of the College.

In 1997, Sri K. Subba Rayudu, former MP, Cabinet Minister, Govt. of Andhra Pradesh, contributed funds from MP LADS for the renovation of the main building (Dutch building). In 2003, Sri UV Krishnam Raju, MP (Alumni), the then Central Minister, contributed funds from MP LADS for the construction of classroom building. The then Minister of State, Govt. of India, Dr. Dasari Narayana Rao (Alumni) sanctioned Rs. 10 Lakhs for the construction of classrooms in the year 2007. Smt. T. Sita Rama Lakshmi, M.P., Rajyasabha, Sanctioned Rs. 20 Lakhs from MP LADS for the construction of 1st Floor on Existing PG Main Block in the Year, 2016. 'Padmabhushan' Dr. K. Chiranjeevi, M.P. Rajyasabha (Alumni) sanctioned Rs. 50 Lakhs from MP LADS for the construction of buildings in the year 2017. The college is ever grateful to all those magnanimous and philanthropic persons who have contributed for the development of the College.

The College, since its inception, has been developing progressively with excellent accommodation in the form of impressive buildings, auditorium, gymnasium and a good playground under the stewardship of successive Secretaries. The College has separate buildings and separate Libraries for UG and PG, and well equipped Science Laboratories with a band of very competent and experienced faculty. Thus it has, over a period of time, evolved into a premier institution of Higher Education in the Andhra University area.

Over the years, the College has produced many outstanding and talented students, who are now occupying higher positions in different fields around the globe.

PROHIBITION OF RAGGING IN EDUCATIONAL INSTITUTIONS

ACT 26 OF 1997

Salient Features :

Ragging within or outside any Educational Institution is prohibited.

Ragging means doing an Act which causes or is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage of modesty or injury to a student.

NATURE OF RAGGING	PUNISHMENT
Teasing, Embarrassing and Humiliating	Imprisonment upto 6 months or fine upto Rs. 1,000/- or Both
Assaulting or Using Criminal force or Criminal intimidation	Imprisonment upto 1 year or fine upto Rs. 2,000/- or Both
Wrongfully Restraining or Confining or Causing hurt	Imprisonment upto 2 years or fine upto Rs. 5,000/- or Both
Causing grievous hurt, Kidnapping or Rape or Committing unnatural offence	Imprisonment upto 5 years and fine upto Rs. 10,000/-
Causing death or Abetting suicide	Imprisonment upto 10 years and fine upto Rs. 50,000/-

A student convicted of any of the above offences, will be expelled from the College.

A student imprisoned for more than six months for any of the above offences will not be admitted in any other college.

A student against whom there is *prima facie* evidence of ragging in any form will be suspended from the College immediately.

STOP THE EVIL OF RAGGING

Ragging is a Criminal offence and a serious act of misconduct. It is also sufficient ground for expulsion from the college. Therefore, students are cautioned not to attend or indulge in any act of ragging. Ragging has a very wide definition and is generally inflicted on the newly admitted students of the College. Whether the ragging is committed by another student or an outsider, it is equally punishable under this act. Generally some senior students are found to indulge in this type of conduct which inflicts immense psychological and physical damage to the newly admitted students.

Students are advised not to entertain any such thoughts and spoil their prospects in life. The State Government and Adikavi Nannaya University and also the Andhra Pradesh High Court have already taken serious note of this type of conduct and directed all educational institutions, especially the Principal, to take stern measures without fear or favour and advised stringent action.

A.P. Prohibition of Ragging Act 1997 has come into force from 4th July, 1997 all over the State prescribing severe punishments, such as fine and imprisonment by Criminal Court, and also suspension and expulsions from the College. Teasing, embarrassment, humiliation, assault, wrongful restraint, wrongful confinement, insult, annoyance, fear, threat, intimidation, outrage of modesty, hurt or grievous hurt, kidnapping, abduction, rape, unnatural offence, death, suicide, any of them may cause irreparable damage to the student and all these are covered in the offence of ragging. The Criminal punishments range from fine of Rs. 1000/- to 10,000/- and or imprisonment from One year upto Life Imprisonment, depending on the seriousness of the consequences suffered by the victim. These punishments and disciplinary action will be more severe, if the erring student happens to be another student of the same college. Those who aid and assist others in ragging are also punishable as abettors.

This Act empowers the Director, PG Centre, Sri Y.N. College to act on complaints immediately and suspend the erring student on the spot. His decision is made final. Express direction and guidelines are given to give wide publicity to these rules and also to constitute a standing committee to deal with the evil of ragging effectively.

Therefore, students should note that ragging in any form ought to be avoided. There is no escape from punishment once the culprit is identified.

the Government to issue appropriate regulatory measures for the functioning of the Colleges and other Higher Secondary Schools, "but no such regulatory measures have been laid down by the State so far".

The court observed that the guideline laid down by the college management was "not designed to prohibit any of the fundamental rights, "but only a reasonable restriction confined to college campus and the code of conduct cannot be flouted in the name of any other freedom".

Once students were admitted to an educational institution, they were bound by the Code of Conduct laid down by the Educational Institutions through the prospectus or college calendar and "it is implicit that they should observe the code of conduct necessary for the proper administration and management of the institution".

The Judges pointed out that the restrictions were 'designed to promote discipline in the educational institution so that the objectives of the educational institution can be achieved and wisdom of laying down those restrictions cannot be challenged after getting admitted to the educational institution.

As the right to admission was not absolute, regulatory measures could be laid down for ensuring educational standards and maintaining excellence in education.

The Bench observed that for giving effect to the objectives for which the educational institution was established either by a Minority Community or by the Majority Community, they could lay down their own rules and regulations governing the teachers, non-teaching staff as well as students. They could also lay down their own code of conduct to uphold their constitutional rights. It was in the exercise of those rights that they had laid down a code of conduct for maintaining discipline and orderly administration. **(Source: The Hindu, 27.05.2003)**

**STUDENTS' CONDUCT – A JUDGEMENT**

A Division Bench of the Kerala High Court on Monday upheld the rights of the college managements to prohibit political activities on the college campuses and forbid students from organizing or attending meetings other than the official ones.

The Bench, comprising Justice KS Radhakrishnan and Justice K Padmanabhan Nair, upheld the Management's right to ban politics on campuses, while dismissing an appeal filed by Sajan Francis SFI Area Committee Member and Second year BA student of St. Thomas College, Pala, against a Single Judge's order.

The petitioner had challenged the action of the principal in disallowing him to write the examination provisionally on grounds of shortage of attendance and ignoring the directive of the Controller of Examinations, Mahatma Gandhi University, to permit him to write the examination.

The court declared that "it is open to the Educational Institutions to prohibit political activities within the college campuses and forbid students from organizing or attending meetings other than the official ones within the college campus and such a restriction would not violate Article 19(1)(a) (Freedom of Speech and Expression) or (C) (Freedom to form Associations or Unions) of the Constitution of India".

Upholding the guidelines of the General Discipline framed by the St.Thomas College Management banning political activities on the campus, the judges expressed the hope that the State Government would come out with appropriate regulatory measures for Government Educational Institutions "as was done in this case by the St. Thomas College". Such measures would achieve the purpose sought to be achieved by the Kerala Government Servants Conduct Rules 1960 as well as Conduct Rules laid down for Subordinate Staff of the Educational Institutions run by the Government and the Affiliated Colleges (ban on employees indulging in political activities)

The Bench while referring to the earlier High Court verdict banning political activities on School campuses, pointed out that the court had directed

COMMUNITY SERVICE CENTRE

College provides shelter and relief material to the victims. During the 2004 Tsunami, the college provided food and shelter to the victims in the college. The college also provided sarees and blankets to some of the Tsunami victims. The college also organised relief activity during Godavari Floods in August 2006. The college distributed 5 Kgs. of rice and a blanket to 340 individual families at Navarasapuram, 290 families at Y.V. Lanka and 800 at Badava in Narsapur Mandal. The college distributed rice and clothes to the victims of fire accident in Ponnappalli slum area in 2010. On behalf of the college, the college management distributed cash, blankets, sarees and household needs to the fire accident victims at new colony Narsapur in February, 2011 and in 2012 June at Ponnappalli. The college management distributed rice, blankets, sarees and household needs to victims of Hudud Cyclone at Visakhapatnam on 22nd October, 2014

In accordance with national policy on skill development, the centre has been transformed into a fullfledged HRD Centre for skill development for training unemployed youth in and around Narsapur, in addition to our regular students. It was inaugurated on 30th August, 2016 by the Hon'ble Vice-Chancellor Adikavi Nannaya University, Prof. M. Mutyalu Naidu.

In tune with the objectives of the national policy on skill development, the Centre shall strive to create opportunities for all to acquire skills, especially youth, women and disadvantaged groups of this rural area. It is contemplating on introducing more short term, market-oriented, demand-driven programmes in the near future.

The Centre has also plans for post-training support, including mentoring for access to markets, credit and appropriate technologies, which is an important part of skill development strategy for self-employment.

Literary & Fine Arts Association

Quiz, Debates and Elocution competitions are conducted periodically by the Literary Wing. Competitions in Fine Arts like Music, Dance and other Theatre Arts are conducted regularly to encourage the students to exhibit their talents in fine arts.

Women Empowerment Cell: A separate Women Empowerment Cell is constituted to take care of specific needs of women. The cell is monitored by a woman staff member as coordinator.

P.G.Library

Ours is the first Private Aided Affiliated College having this unique opportunity in Andhra Pradesh. It is a prestigious centre of our college with a view to perpetuate the ideas and philosophy of Mahatma Gandhi. The objective of the centre is to promote, organize and undertake the study of life and thought of Mahatma Gandhi and for study and dissemination of Gandhian thought, to promote activities both for the younger generation and for the more matured Gandhian activists and workers, and to translate the same into social life for the benefit of the Nation. STUDENTS COUNCIL AND STUDENTS WELFARE

The students have facilities for activities like Physical Education, Literary and Fine Arts, Community Service, etc.

Student Representatives:

Whoever is first in the class on merit basis will be the representative of the class. He will represent matters relating to the said class to the Director, Dr.C.S.Rao. P.G Centre, or the In-Charge of the Department as the case may be.

Student Council:

The P.G. Student Council consists of representatives of all the classes and the staff members of Student Welfare Committee. Principal will be the Chairman. Director, P.G.Centre will be the Convenor. The Students Council meets at least twice in a year or as and when required to discuss the measures to be taken for the welfare of the students.

STUDENT CHARTER

Every stakeholder of Higher education has a role to play for quality enhancement and sustenance. The stakeholders such as the Government, management, teachers, students and the external quality assurance agencies, have an important role in ensuring quality of higher education. The National Assessment and Accreditation Council (NAAC) strives to play a catalytic role in synergising the stakeholders efforts.

Of all the stakeholders mentioned above, the students have a unique role to play in ensuring quality of Higher Education Institutions (HEIs). Firstly, the students should realize that they have the right to quality education, and that it is the responsibility of the HEIs to provide quality educational experience to learners. Secondly, the students should equally be aware of their responsibilities, which in turn will help the institutions to provide quality education. This means that the students should demand quality education and demonstrate their commitment to quality education by accepting their responsibilities. Otherwise, the HEIs will have very little motivation for quality enhancement.

A) Responsibilities of the Institution towards Students

The institution must

- Communicate its Goals and Objectives systematically and clearly to all students.
- Offer programmes that are consistent with its goals and objectives.
- Offer a wide range of programmes with adequate academic flexibility.
- Obtain feedback from students on the initiation, review and redesign of programmes, if and when necessary.
- Facilitate effective running of the teaching-learning programmes.
- Implement a well-conceived plan for monitoring student progress continuously.
- Ensure that the student assessment mechanism is reliable and valid.
- Provide clear information to students about Admission and Completion requirements for all programmes, the Fee Structure and Refund Policies, Financial Aid and Student Support Services.

RULES AND REGULATIONS

The students admitted into P.G.Courses of this Institution are required to carefully read the general instructions given below, and give an undertaking affixing his / her signature for the purpose of College Record. This is given at the time of admission to take any necessary action in case of any deviation / violation, during the course of study.

1. The student admitted into P.G.Courses should report in the P.G. Office of the College within 5 days from the date of admission and those who fail to report within the stipulated period will be losing admission.
2. Non-submission of the following Original Documents will lead to disqualifying a student from getting admission into P.G. Courses.
 - (a) Provisional Pass Certificate of the qualifying degree
 - (b) Original Marks Memo,
 - (c) Original Caste Certificate for those who belong to SC, ST, BC.
 - (d) Transfer Certificate
 - (e) Study and Conduct Certificates and
 - (f) Migration Certificate (in respect of the students of other University only.)
3. As per G.O.Ms No.90 dt 30-7-2002, the Authorities of the colleges are directed to retain the original SSC / 10th Class Pass Certificate cum Marks Memo and Transfer Certificates of Scholarship holders, compulsorily in their respective institution till the completion of courses or till the scholarship holders leave the institution whichever is earlier.
4. The students are directed to submit two sets of xerox copies of all documents, duly attested, to the P.G. Office. The Originals will not be returned until the completion of the course.
5. The students discontinuing their course of study are required to clear all the dues payable to the College as per the rules prescribed by the Government. Otherwise, T.C. will not be issued and the Original Documents will not be returned.
6. The Institutional authorities reserve the rights to issue T.C. or take any disciplinary action if his / her behavior is contrary to the code of conduct.

7. A student who completed one Professional Degree or Post Graduate Degree, and joined another P. G. Course is not entitled to claim scholarship under any category from the Government.
8. The students are required to clear all the dues payable to the College well before the conduct of University Examinations.
9. The students who fail to pay the Tuition Fee before the commencement of the Semester or beginning of the Academic year will be imposed a fine of Rs.50/- per day. They will not be allowed to the classes if they fail to pay the fee within 10 days from the last date.
10. Difference of Tuition Fee & Special Fee, if any, in the reimbursement by the Government shall be paid by the students.
11. The students falling short of 75% of biometric attendance will not be permitted to appear for the University Examinations and Fee Reimbursement / Scholarships will not be issued by the government. If the student is absent even for one period, it will be treated as absent for that entire session.
12. The College functions in two sessions FN and AN from 9.00 A.M. to 4.00P.M. with a Lunch Break from 12.00. P.M. to 1.00 P.M.
13. The students should confine to their respective classrooms during the college working hours and should not loiter in the corridors. If any student is found on the campus during the class hours, he / she is liable to pay a fine of Rs.25/-.
14. The students should compulsorily hold their Identification Cards so as to be verified on demand by the Institutional authorities.
15. The students should follow Dress Code and come neatly dressed.
16. It is mandatory that they should attend the Independence Day and Republic Day Celebrations.

17. Disciplinary action will be taken against those who violate the code of conduct.
18. The students are required to compulsorily participate in the workshops, seminars, conferences and other academic programmes organized by the respective departments.
19. The student organized functions / activities within the College campus shall be performed between 3-00 p.m. and 6-00 p.m. The students are not permitted to use the Public Address System which may cause disturbance to normal academic atmosphere.
20. The students should see that the campus is kept clean. They should not litter the campus with papers / wrappers, etc.
21. "Ragging is prohibited as per the decisions of the Supreme Court of India in writ Petition No.(C) 656 / 1998". Stringent disciplinary action & prosecution will be taken against those who involve in Ragging / Eve Teasing.
22. The College P.G. Library is kept open for students from 9.00 A.M to 7.00 P.M. on all working days.
23. The students should strictly follow the rules of the Library in borrowing and returning books. They will be imposed fines if they violate Library rules. They should obtain "No Dues" certificate from the Library authorities to receive the Hall - Tickets for the University Examinations.
24. Students should attend Internal Examinations, failing which they will be liable to pay a fine of Rs. 50/- per examination.
25. The Hostel students are not permitted to celebrate any Religious and Social functions.
26. The Hostel students should ensure strict discipline by following the Code of Conduct and establish harmony in the hostel premises.
