

PURPOSE OF THE MoU


- This MoU sets out the terms and responsibilities by which the Parties will work in close a)
- The MoU provides for broad-based initiatives between the Parties. The MOU establishes a b) foundation for a more robust future relationship between the two Parties. It reflects a shared value and focus for seeking joint opportunities between Parties towards their respective vision, mission and program focus.
- The purpose of the MoU is to specify the roles and responsibilities of the Parties in relation to c) working to combat human trafficking.

SCOPE OF ACTIVITIES/PROJECTS

The scope of collaboration on academic and research activities/projects under this MoU may include, but is not limited to the following: i.

- Student internships;
- Exchange of scholarly publication and information; ii.
- Collaborative research programs or projects in the field of bonded labour, any forms of human iii. trafficking and related issues;
- Collaboratively organize and co-sponsor academic discourse such as symposia, seminars, iv. workshops, conferences and training programs;
- Cooperation in the development of education generally, including the potential of offering joint V.
- Conduct surveys to find out the root causes of human trafficking or missing cases or migrating vi.
- Survey and identify any child labor or child beggars in the locality report and counsel if any vii.
- Visit Railway and Bus stations to spot any abandoned children, child beggars report if found viii.

- ix. Visit Shelter home understand their functions, issues faced, support required from Govt. Volunteer at the NGO when required. Organize any events or recreational activities for the children
- Visit Juvenile Home understand their functions, interact with juveniles to document their issues / goals. Study the living conditions of juveniles and recommend best practices. Counsel juveniles.
 Organize any events or recreational activities.
- xi. Interact with SHRC understand the most no. of human rights violated. Study the measures taken to safeguard the human rights. Participate in the inquiry process. Conduct research in any relevant field suggested. List the NGO rendering impacting environment to children
- xii. Conduct awareness campaigning in communities, panchayats, villages, schools, junior colleges and rallies to urge more sensitization.
- xiii. Visit local NGO working on human rights or children understand their functions, issues faced, support required from Govt. Volunteer at the NGO when required. Organize any events or recreational activities for the children
- xiv. Visit Police station understand the requirement and help them with information or intellects on cases of trafficking.
- xv. Get equipped with existing acts such as: Article 23(1) Immoral Traffic (Prevention) Act, 1956, POCSO Act, POSH Act and Juvenile Justice Act, Victim compensation scheme under S357A of Cr.PC,
- xvi. Raise RTI on any of the existing gaps in information and execution of any acts, schemes, rights etc.,

TERM AND TERMINATION

- 1. This Memorandum of Understanding will enter into force on the day of the last signature affixed by the PARTIES and shall remain in force until terminated by either Party.
- 2. Either Party may terminate this Memorandum of Understanding without cause uponninety (90) days' written notice to the other and may terminate this Memorandum of Understanding for cause upon fourteen (14) days' written notice to the other.
- 3. Upon termination of this Memorandum of Understanding, the PARTIES will take allreasonable and necessary measures to conclude any Services alreadycommenced in accordance with this Memorandum of Understanding.
- 4. The provisions of this Memorandum of Understanding will survive any termination, to the the extentnecessary to permit an orderly settlement of accounts between the PARTIES.

CONFIDENTIALITY AND USE OF NAME:

Both Parties are entitled to refer and mention the name of the other to propaganda and publicize their initiatives to the public for awareness which shall not be construed or violation of any confidentiality right or obligation and both Parties hereby exclusively agree to use others name for the aforesaid purposes.

GOVERNING LAW AND JURISDICTION:

This MoU shall be governed under the Indian Laws and courts at Naraspur or Bhimavarm will have exclusive jurisdiction if in case of any conflict arises between the Parties.
