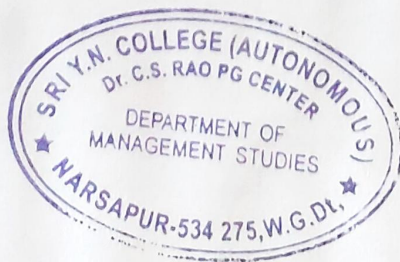
1. To prepare the syllabi and model question papers for the degree I, II and III years for the academic year 2021-22 by making appropriate modifications to the University syllabus.
