Obligations of Department of chemistry, Dr.C.S.Rao P.G.Centre Sri Y N College,Narsapur.

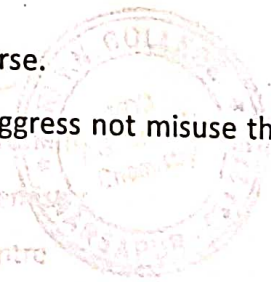
Department agrees shall commence on the date stated above, and shall be valid and enforceable
