ORDER:-

The Sri Y.N. College (PG Courses), NARSAPUR - W.G. Dist. has applied for starting New Un-Aided PG Course for the academic year 2010-2011, vide ref 2nd cited.

After duly examining the reports submitted by the JIC and that of University, APSCHE in exercise of the powers vested in it vide ref 1st cited, hereby accords permission to Sri Y.N. College (PG Courses), NARSAPUR - W.G. Dist. for starting the following New Un-aided PG Course from the academic year 2010-2011:

The permission accorded is subject to the fulfillment of the following conditions:

- 1. The management should obtain the approval of affiliation for the Course, Intake and Medium of instruction, from the concerned University during this academic year only, i.e. 2010-2011, failing which the permission accorded shall remain cancelled without any further notice.
- 2. The management should renew their affiliation each academic year by the concerned University until permanent affiliation is granted.
- 3. The college shall fulfill all requirements necessary for the Establishment of New Private Un-aided Degree College and for running the existing UG Courses & PG Courses as stipulated by the Government from time to time with regard to land, accommodation, playground facility, parking area, fire safety and other infrastructural facilities etc.
- 4. The Management shall fulfill all the requirements for starting a P.G. Course in accordance with (a) The rules issued by the A.P.State Council of Higher Education and (b) The norms prescribed by the University committee for affiliation.
- 5. The staff appointed should be qualified as per the rules and regulations prescribed from time to time by the University/Government.
- 6. The management shall follow the rules issued by the Government from time to time with regard to reservations in respect of admission of students and appointment of staff.
- 7. Infrastructure like Buildings, Land, Play ground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
- 8. The management should not make any claim for any grant-in-aid either now or in future.
- 9. Without prior permission of the AP State Council of Higher Education/Government of Andhra Pradesh, the College (a) should not be shifted to any other place (b) should not change the name of the College (c) Should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa.

- 10. The accommodation shown for the College should not be used for any other purpose other than running the college for which permission is given by the APSCHE.
- 11. The management should not change the Courses / Combinations, intake and media sanctioned in these proceedings without prior permission.
- 12. The management of the College shall set up a complaints cell as per the Supreme Court guidelines for dealing with sexual harassment related cases & ragging and action should be initiated against erring individuals without any delay.
- 13. The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh U/S 21-A of A.P. Education Act 1982.
- 14. The Secretary / Correspondent of the College is informed to exercise his powers as per the provisions of the AP Education Act 1982.
- 15. The College shall not make admissions into the Courses sanctioned in this proceedings until issuance of affiliation order by the concerned University.
- 16. The management of the college shall obtain Fire Safety certificate for the college building.
- 17. The management of the college shall provide parking area within the premises of the college / within 100mtrs from the college building to an extent of 20% of the total built-up area.
- 18. A library shall be established with adequate number of titles, books and journals.
- 19. The faculty shall be recruited as per norms/Procedures, qualifications etc., as prescribed by the University/Government.
- 20. The Management should provide the laboratories with all the necessary prescribed equipment. The college also should have an English language lab.
- 21. The College concerned is not entitled to forward any recommendations for the issue of bus passes and scholarships to the students admitted into this Course.
- The management should establish Computer lab and procure licensed software and the prescribed hardware wherever applicable.
- 23. The management should establish a website for the college and keep all the necessary information in the website.
- 24. The Conditions mentioned at SI.No.17,18, 19, 21 & 22 will have to be complied with on priority basis before affiliation.
- 25. If the Management either fails to fulfill any of the conditions mentioned above or violates rules/guidelines laid down by University / Government / APSCHE, issued from time to time, the permission granted will be withdrawn.

With reference to the above, I am by direction to inform that your college is permitted to start New PG Course, M.Sc. (Organic Chemistry) for which necessary Conditional Affiliation has been granted for the academic year 2010-2011 subject to fulfillment of deficiencies/ conditions laid down in the Inspection Report, APSCHE/ Govt. norms and also other requirements as per the Anahra University statutes, Rules and Regulations.

The Vice-Chancellor directs the college to adhere and implement the following:

- 1. The staff should be recruited separately for this purpose with Ph.D., NET/SLET qualification in the particular subject/area.
- 2. The management are required to submit the list of UG and PG staff with photographs and Bio-data immediately.
- 3. There should be a clear demarcation between UG and PG Staff. The salary and other emoluments should commensurate with the revised UGC Scales

- 4. There should be a separate building for laboratory and library for the PG Courses. There should not be any link between UG and PG courses.
- 5. A well-qualified Director must be appointed for PG courses exclusively.
- 6. There should be a good play ground and recreational facilities. It is also desirable to provide hostel facilities at least for a minimum number of boys and girls

The Management shall abide and be bound by the provisions of Andhra University Act (now the A.P. Universities Act, 1991), Statutes, Regulations, Standing Orders of the Executive Council that are now in force and that may be laid down from time to time in future. The management has to request the University for nomination of University Representative on the Governing Body immediately. The Governing Body shall meet at least four times in an academic year.

The rules of reservations that are now in force and that may be prescribed from time to time in future have to be followed in making appointments (both teaching and non-teaching) with regard to service conditions and payment of salaries to the Staff, the rules of the state government/UGC are to be followed.

The managements of Affiliated Colleges should take the responsibility of fulfilling deficiencies as pointed out by the Inspection Commission and submit proof of evidence (like Photographs, bills, indents, etc) substantiating that they have fulfilled the same before the classes commence to the CDC. The University has every right to impose fine/cancel affiliation if any of the Colleges violate the rules and regulations or if they do not fulfill the requirements as mentioned above.

The College should strictly follow the Academic Calendar and calculate attendance of students as per the University rules. The presence of the University Representative must be ensured at the meeting of the Governing Body (four times per year) invariably following the usual procedure laid down thereupon. An extract of the important provisions of Chapter-XII of Andhra University Code Volume-I may be collected from C.II Section, A.U. for your guidance.
