ORDER:

In the circumstances reported in the references read above, Government permit the Management of Y.N.College, Narsapur, West Godavari District to start M.A.(English) M.A.(Public Administration) and M.Com. during the academic year 1989-90 subject to the fulfilment of the following conditions.

- (i) There should be no financial commitment to the State Government now or ever in future on the introduction of the above Post Graduate Courses. ~~xxxxxx~~ The Management should not collect capitation fee;
- (ii) The Management should provide the required accommodation to house the post graduate courses or should show the amount required for construction of building for the purpose;
- (iii) The Management of the College should deposit Rs.15.00 lakhs (Rupees fifteen lakhs only) for 3 courses towards Corpus Fund in the Joint Account of Commissioner of Collegiate Education and the Management.
- (iv) The recruitment of the teaching staff to the New courses shall be made through ~~Andhra Pradesh~~ Andhra Pradesh College Service Commission.
- (v) Admissions to the course should not exceed 40 for each course (i.e.) three courses.
- (vi) Admissions to the courses shall be on the basis of merit in Entrance Test conducted by the University to which the college is ~~an~~ affiliated.
- (vii) The Management should fulfill all the conditions stipulated by the Inspection Commission of the University and also the conditions stipulated by University/Government/U.G.C.from time to time
- (viii) The fee charged shall be as fixed by the Government for the courses.
- (ix) All the 3 (Three) courses should start only after the usual conditions are fulfilled and accepted by Commissioner of Collegiate Education.

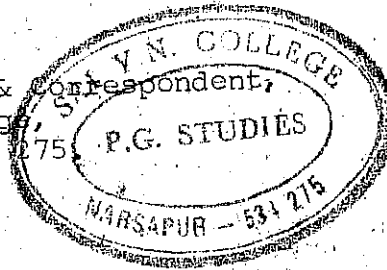
