either now or in future subject to fulfilling the following conditions including conditions stipulated in the Inspection Commission Report of the University:-

- i) Rs.5.00 Lakhs for M.C.A/D.C.A shall be deposited towards Corpus Fund in the Joint Account of the Management and the Government represented by the Regional Joint Director of Higher Education concerned in any of the branches of a Nationalised Bank.
- ii) The management shall provide additional accommodation with Plinth area of 1,000 Sq.ft for the proposed P.G.Course.
- iii) Entirely new infrastructure of accommodation, staff, library and Laboratories as per the U.C.C guidelines for this new course must be provided.
- iv) The course must be instituted and operated as per the existing (or modified from time to time) University rules and regulations regarding Syllabus, admission and examination of the said course.

and also other conditions stipulated in G.O.Ms No.29, Education Department, Dated:5.2.1987.

2. The Secretary, Andhra Pradesh State Council of Higher Education, Andhra Pradesh, Hyderabad/Commissioner of Collegiate Education, Andhra Pradesh, Hyderabad is requested to ensure that the managements of the above colleges fulfill all the conditions prescribed in the rules including those mentioned in para (1) above.

In this connection, I am to inform you that the members of the Commission are eligible for payment of inspection fee of Rs.200/- Travelling allowance of 1 1/3 first class fare both ways Distance allowance of Rs.3/- per each 100 Kilometres or part thereof, D.A. of Rs.40/- per each day of inspection Rs.0.65 Ps. in case of journey by Road/Canal and other incidental charges as may be claimed for each college.
