- 3) Extend support for social services activities being initiated by Meera Aziz Educational Society .

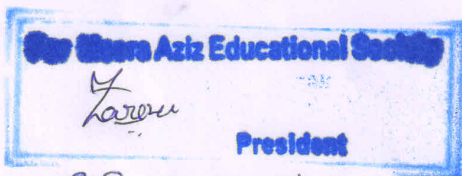
General Terms and Conditions
