
It is also resolved that the students can be allowed to do projects on the **Community based issues** in case, they don't get permissions from the companies.

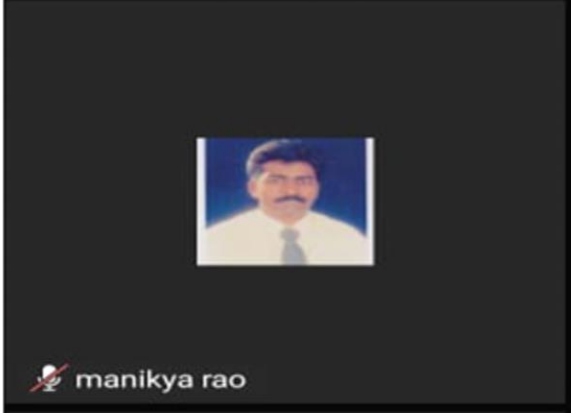

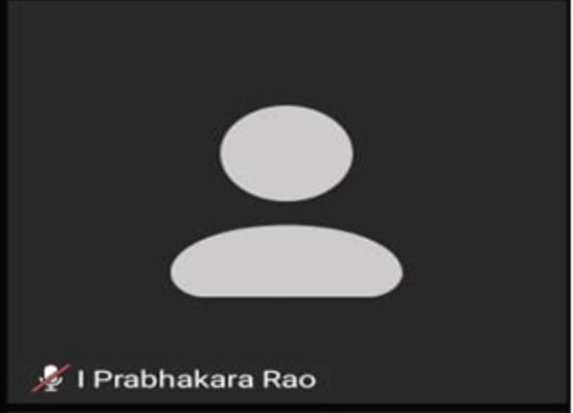
