## 2 PURPOSE:-

The purpose of this MOU is to promote and enrich Teaching and learning process and exchange of knowledge, information and expertise between UG students of party1 and party2.

## 3 TERM OF MOU: -

This MOU is effective upon the day and date signed and will be executed by the party's from 13-7-2022 and shall remain in full force and effect for 3years till June 2025. This MOU may be terminated, without cause, by either party upon two months written notice which notice shall be delivered by hand or by certified mail to the address listed above.

## 4. RESPONSIBILITIES OF PARTIES:-

- The senior faculty of party1 will train the teachers of party 2 in the areas of teaching Telugugrammar, poetry, prose and supplementary readers to student effectively.
- The party 2 may absorb some of these students of party 1 as their teaching faculty, provided the students of party 1 met with all the requirements of party 2.
- Mere participation of UG students of Party 1 in teaching of students of Party 2 according to this MOU does not carry any right or any legal entitlement to demand for placement with Party 2.
- The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties
