### 1. Parties

The Memorandum of Understanding (herein after referred to as MoU) is made and entered into by and between the **Department of Sanskrit, Sri Y N College (Autonomous), Narsapur, W.G.Dt., Andhra Pradesh (Herein after Party 1)** and the **Global Sanskrit Forum, Delhi, (Herein after Party 2)**

### 2. Purpose:

The purpose of this MoU is to promote and enrich Teaching and Learning process through exchange of Faculty for Guest lectures and to provide an opportunity for the students to teach their peers.

### 3. Activities:

The two institutions agree to:

- Encourage the development of Research Projects involving faculty and students from both the Parties.

- b. Cooperate with each other in the conduct of guest lecturers in Sanskrit, and in organizing various academic and Sanskrit language oriented Seminars, Workshops, Events and Competitions such as Quiz, Elocution, Essay Writing, Performance of Skits and the like by students at each other's institutions.

#### 4. Duration of the agreement:

This MoU is valid for five years starting on the date that it is signed by Sri Y N College (A), Narsapur and Global Sanskrit Forum, Delhi. The MoU can be terminated by either one of the two parties with a written notification three months in advance of the anticipated termination. It may also be extended by mutual agreement of the parties involved.

Any difficulty or controversy that may arise between the collaborating institutions will be amicably resolved by the authorities of both institutions.


#### 5. Responsibilities of the Parties

- The signatories of both parties permit their faculty and students to attend and participate in Sanskrit guest lectures, seminars, workshops along with various other language oriented academic competitions such as quizzes, role-plays, elocution, essay writing, performances of skits, dramas and the like.
- The Parties shall entrust a faculty member in their respective institutions to liaison between the parties.
